Emergency and First Aid Procedures

Skin: Flush with cold water for at least 15 min. Remove clothing and soak contaminated area in 0.13% iced aqueous Zephiran Chloride solution for 30-60 minutes; contact physician immediately.

Eyes: flush with plenty of water for at least 30 min. Do not use Zephiran Chloride solution on eyes.

Ingestion: Do NOT induce vomiting! Then give 1 oz. Of magnesia w/equal amount. In case of ingestion give plenty of water, Exposure, get medical attention.

Inhalation: Remove to fresh air; give oxygen. Do not use mouth to mouth method.

Section VII — Precautions for Safe Handling and Use

Steps to be taken in case material is released or spilled: Collect large quantities with absorbent material, and flush with plenty of Water.

Waste disposal method: Dilute with plenty of water and neutralize with Caustic Soda solution. Discard in accordance with federal, state Local regulations.

Precautions to be taken in handling and storing: Residue left in container may be harmful.

Other precautions: Use rubber gloves and goggles, in contained area use ventilation.
